When you enter into a discussion with a real estate agent regarding a real estate transaction, you should from the outset understand what type of agency relationship or representation you wish to have with the agent in the transaction SELLER'S AGENT A Seller's agent under a listing agreement with the Seller acts as the agent for the Seller only

Important DRE Regulations Regarding Referral Fees & Loan

Furthermore, a real estate agent owes his or her client a fiduciary duty of utmost care, integrity, honest, and loyalty in their dealings Q: Can a real estate licensee pay a referral fee or finder's fee to an unlicensed person? A: No, if the resulting transaction falls under RESPA RESPA generally prohibits a real estate agent
